MINIMUM CLEARANCE TO COMBUSTIBLE MATERIALS

Please read the section below carefully as clearances depend on whether the optional airmate convector or the rear heat deflector is installed on the stove. Measurements "From Unit" are from the top plate of the stove to a side wall or to a corner, and from the rear heat shield to a back wall.



NOTE: Be aware that local Codes and Regulations may override some clearances listed in this manual. Check with your local inspector. Clearances to combustibles are for the safety of the property. To avoid overheating and damaging the appliance these clearances should be maintained for non-combustibles also.

Ri50 - MASONRY FIREPLACE INSTALLATION








